Agenda - 4 Dr Goyal gave information about application for GSIRF and NIRF, DPR submission for PM USHA grant and all committees that has to be constituted as autonomous college.

Resolution – Committee noted the point and it was resolved to fill up all the pending AQAR.

Agenda - 5 Dr Nerlekar outlined the functions of IQAC. He emphasized on quality benchmark that has to be set by IQAC. IQAC has to give guidelines for the activities to be performed year around.

Resolution – It was agreed to decide a theme based on which all departments will perform one activity per year if not semester. Emphasis was laid on initiation of Certificate Courses.

Dr Nerlekar asked the college to adopt outcome-based education. Teaching methodology and exam pattern has to be changed. PO attainment needs to be defined

Resolution – IQAC will meet the exam committee to decide the format for both CCE and SEE and make sure that all departments follow the directives.

Mr H R Pandey asked about the NAAC accreditation that is due in 2026

Dr Nerlekar was very clear in his stand that as an autonomous college we shall be going for NAAC in 2030.

▶ Resolution – It was resolved to gear up college and prepare it for 2030 NAAC.

Dr Nerlekar also emphasized on regular meetings of IQAC internal members at least once a week so as to decide the quality benchmarks. If need arise to change or add to vision and mission statement of college.

Resolution – To assess quality; feedback from all stakeholders has to be collected, analyzed and implemented.

Meeting was over at 12:45 pm with concluding remarks by Dr J. J. Vora. Next meeting is scheduled on 25th October 2024 at 3 pm.
