- "MGSI" means M G Science Institute (Autonomous).
- "Rules" means the M G Science Institute (Autonomous) Admission Rules –
 2025 (Science Stream).
- "Admission Committee" means the MGSI Admission Committee framed for online admission to MGSI (Autonomous) for the programmes mentioned in Section 1.
- "Gujarat Board" means the Gujarat Secondary and Higher Secondary School Examination Board, established under Section 3 of the Gujarat Secondary and Higher Secondary School Board Act, 1972 (Guj. 18 of 1973).
- "School" means a higher secondary school (XII, 10+2 pattern).

4. Eligibility for Admission

- 4.1 For admission, a student who has passed the qualifying examination in the subjects prescribed by M G Science Institute (Autonomous) from time to time from
 - 4.1.1 The Gujarat Higher Secondary Education Board
 - 4.1.2 The Central Board of Secondary Education (CBSE)
 - 4.1.3 The Council of Indian School Certificate Examination, New Delhi (CISE)
 - 4.1.4 The International Baccalaureate (IB)
 - 4.1.5 National Institute of Open Schooling (NIOS)
 - 4.1.6 A student who has passed the qualifying examination from any State other than Gujarat
- 4.2 A student who has passed the qualifying examination from other than Gujarat Board or other than CBSE schools of Gujarat State shall be required to submit the **Provisional Eligibility Certificate (PEC)** from Gujarat University before registration.
- 4.3 The following shall be the eligibility criteria for admission in the first year of the programmes mentioned in 3,
 - 4.3.1 **B.Sc.**: A student should have passed the qualifying examination in the Science Stream.
 - 4.3.2 **B.S. DSA:** A student should have passed the qualifying examination with Science Stream or with Commerce Stream with Mathematics or Statistics as one of the subjects.
 - 4.3.3 **B.S. Biotechnology**: A student should have passed the qualifying examination in the 12th Standard Science stream with Group B subjects (Biology).
 - 4.3.4 **M.Sc. Chemistry:** A student should have passed the B.Sc. Chemistry from a recognized university.
 - 4.3.5 **M.Sc. Geology**: A student should have passed B.Sc. Geology from a recognized university.
 - 4.3.6 **M.Sc. Geoinformatics**: A student should have passed B.Sc., B.A. Geography, or B.Sc. with Geography from a recognized university.

- 4.3.7 **M.Sc. Microbiology**: A student should have passed B.Sc. Microbiology from a recognized university.
- 4.3.8 **Diploma in Geoinformatics**: A student pursuing a B.Sc. or B.A. Geography or B.Sc. Geography from a recognized university is eligible.
- 4.3.9 **PG Diploma in Nutrition and Dietetics**: A student should have passed B.Sc. Life Sciences, Chemistry, or Home Science from a recognized university.

5. Reservation Policy

- 5.1 For admission, the seats shall be reserved for the students who are of Gujarat origin and falling under the respective the following categories and proportions:
 - Scheduled Caste: 7%
 - Scheduled Tribe: 15%
 - Socially and Economically Backward Classes: 27%.
 - Physically disabled students: 5%
 - Economically Weaker Section (EWS): Supernumerary seats 10%, of which 33% are reserved for girls
 - Sports/NSS/NCC/Cultural Quota: 2% Supernumerary seats
 - Ex-Servicemen and Defence Quota: 1% Supernumerary seats One percent of available seats shall be reserved for the children of Defence personnel and Ex-Servicemen.
- 5.2 A student seeking admission under a reserved category shall be required to produce a valid Caste Certificate. In addition, a student belonging to the SEBC category must also submit a certificate of non-inclusion in the creamy layer, issued by the competent authority of the Government of Gujarat.
- 5.3 No Caste Certificate shall be considered valid unless it is duly stamped, signed, and issued by an authority empowered by the Government of Gujarat.
- 5.4 No certificate of non-inclusion in the creamy layer shall be considered valid unless it is duly stamped, signed, and issued by an authority empowered by the Government of Gujarat. This certificate, issued by the competent authority, shall remain valid for a period of three years from the date of issue.
- 5.5 If a student fails to submit the required certificates within the stipulated time, his or her admission shall be considered under the unreserved or respective category in the subsequent admission round.
- 5.6 The admission of a student from a reserved category on a reserved seat shall be valid

on the subject to the verification of caste certificate by the authority empowered by the Admission Committee of MGSI. In case the caste certificate is found invalid on verification, he/she shall not have the right to claim his/her admission on a reserved seat and if he/she has already been granted admission, such admission shall be canceled. Admission of such students may be continued in case of availability of vacant unreserved seats, subject to the condition of eligibility of merit.

- 5.7 After granting admission to all the students of reserved categories on respective reserved seats, the remaining vacant category seats of Scheduled Caste (SC) shall be transferred to Scheduled Tribe (ST) and similarly the remaining vacant seat of Scheduled Tribe (ST) shall be transferred to Scheduled Caste (SC) by the Admission Committee after having obtained sanction from the competent authority of the MGSI.
- 5.8 After granting admission to all the students of EWS category, on respective reserved seats, the remaining vacant reserved category seats of female students (EWS category) shall be transferred to male students (EWS category) by the admission committee after having obtained sanction from the competent authority of the MGSI.
- 5.9 After granting admission to all the students as mentioned in 5.7 above, the remaining category vacant seats (if any) shall be transferred to the unreserved category seats after having obtained sanction from the competent authority of the MGSI.

Reservation for Physically Disabled Students

Five percent (5%) of the available seats in each category shall be reserved for persons with disabilities, in accordance with the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996), provided the candidate is capable of performing academic activities in the respective programme.

A student with a disability must submit a disability certificate issued and duly signed by the Civil Surgeon.

Explanation: "Person with Disability" means a person suffering from not less than 40 % of any disability as certified by a competent medical authority.

6. Supernumerary Seats

Two percent (2%) supernumerary seats shall be allotted to students who have achievements in NSS, NCC, Sports, or Cultural activities at the State or National level. The criteria and verification will be carried out by a competent committee constituted by MGSI. To claim admission under this category, a student must contact MGSI with supporting documents within the stipulated time.

7. Distribution of Seats between Students of Gujarat State and Other States

For admission, the available seats shall be distributed as follows:

- Ninety percent (90%) of available seats for admission shall be reserved for students who
 have passed the qualifying examination from schools located (All valid boards mentioned
 in section 4.1. In case of NIOS the student should be a resident of the state (Gujarat) for
 the last 10 years.
- Ten percent (10%) of available seats for admission shall be reserved for students who
 have passed qualifying examinations from schools located in states other than Gujarat
 State.

8. Preparation of Merit List

The merit list of the students, who have applied for admission in the manner prescribed by the Admission Committee, within the prescribed time limit and who are found eligible for admission under these rules, shall be prepared in the following manner, namely –

• For the student who has passed the qualifying examination from any of the Boards mentioned in the 4.1, the percentage of marks up to four decimal points obtained in the external theory shall be the merit marks.

In case of a tie in merit marks, the following criteria shall be used in sequence to determine the merit order:

- 1. Aggregate marks obtained in the qualifying examination
- 2. Marks obtained in the English subject in the qualifying examination
- 3. Aggregate marks of the SSC Examination or equivalent examination
- 4. Date of birth (preference will be given to the older candidate)

For students other than Gujarat Secondary and Higher Secondary Education Board, Gandhinagar. The Boards/Universities that have issued the mark sheets with theory and practical as well as external and internal (if any) marks must produce certificates issued by the School/Board/University that clearly indicate the classification of theory and practical (and external – internal if any) marks otherwise their registration form will not be accepted. The merit list will be strictly on external theory marks only. A student whose mark sheet includes CGPA/Grade only and does not include marks/percentage has to produce an equivalent certificate issued by the School/Board showing the conversion of Grade/CGPA into marks or percentage, otherwise, he/she will not be eligible for the admission process.

If the mark sheet indicates the combined marks of theory and practical, a student has to produce a certificate from the school principal indicating the bifurcation of practical and theory marks separately, otherwise forms cannot be verified.

9. Correction of Marks

In case of change in marks of a student in the qualifying examination, such students shall produce a letter to that effect by the competent authority or the corrected mark sheet issued by the Board, before the Admission Committee. This must be done at least one day prior to the commencement of the admission process but no later than seven days from the date of receipt of the revised marks. In such cases, the student shall be placed appropriately in the merit list based on the corrected marks.

10. Registration for Admission

Admission process of GCAS Portal:

Online Admission Process for Students seeking admission at MGSI:

Step 1: Go to the website GCAS: https://gcas.gujgov.edu.in/

Step 2: **Registration** Enter your name, date of birth (as per the HSC mark sheet), mobile number, and email ID. Your username and password will be sent to your registered mobile number and/or email. Candidates are advised to retain these credentials for the entire admission process..

Step 3: **Process after Initial Registration**: Log-in through the above link/ website, using your User ID and password. Students can fill in forms for different universities and colleges. To apply for this institute, select the Gujarat University, and then select the M G Science Institute (Autonomous)

Step 4: Fill in the particulars in the following steps.

4.1. Basic Details: Enter all relevant information and *Click save Button and next after completing particulars.*

4.2. Academic Details: Fill in the details as per your Marksheet, Category Certificate, etc. (documents), If there is any discrepancy in entered data and original documents verification at the time of admission, it will be liable to cancel your right to admission in that particular round.

Click save Button and next after completing particulars

4.3. Upload Documents:

- Applicants must have the latest Photo and Signature with a maximum size of 50Kb (JPG/JPEG Format).
- Applicants must have the below documents with a maximum size of 200Kb for

complete application fill-up.

- All Mark-sheets of the qualifying Exam (If the Original Mark-sheet is not available, you can upload a copy of the online mark sheet)
- School Leaving Certificate (Optional)
- Caste Certificate (If Applicable)
- Non-Creamy Layer Certificate with valid Period (If Applicable)
- o Differently abled certificate (If Applicable)
- EWS Certificate (If Applicable)

Click save Button and next after completing particulars.

4.4 **Choice – University/Program/Colleges/Medium**: The candidate may fill in the college choice of different universities and within each university's different colleges as per choice from the given list on the website. Select MGSI in Gujarat University.

Click save Button and next after completing particulars

Step 5: LOCK: After verifying all details, if you are sure that no change is required in the online admission form entry, press the LOCK button and give consent to lock your particulars. No change of preference of colleges and other particulars will be made thereafter. Make online payment of the mentioned fees towards the admission process fees through the Payment Gateway

Step 6: **Submit and Download Application Form:** Before submitting the form, verify the details and data you filled in your application form; the allotment will be on the data you entered. If you have entered the wrong merit data, your admission will be canceled.

Step 7: **Reporting at MGSI with original documents**: The student will have to report to the college with all original mark sheets, category certificates (if any), and other original documents as well as copies and the admission offer letter of the college and mobile with the registered number of the student.

Note:

- 1. Students coming from schools located out of Gujarat state are mandatorily required to obtain a Provisional Eligibility Certificate (PEC) from the Gujarat University through the following link before registration: https://fees.gujaratuniversity.ac.in
- 2. If a student has made more than one registration, the registration made at the later stage(the recent one) shall be taken into consideration for admission and all other registrations shall be treated as canceled.

11. Admission Procedure

The admission procedure shall be online in the following manner:

- 11.1 The Admission Committee shall publish the schedule of the admission process on the MGSI website.
- 11.2 Considering the seat matrix, the Admission Committee shall prepare a merit list of the eligible students who have applied, after online verification of the documents submitted.
- 11.3 The merit lists shall be displayed on the MGSI website and the college noticeboard.
- 11.4 Students on the merit list will receive a link of the registration form from the college ERP.
- 11.5 As per the schedule displayed on the MGSI website, a student has to physically report to the college by taking a print of the GCAS application form, and MGSI registration form along with all documents mentioned in point 12.
- 11.6 At the college, after verification of documents, students will be shown the available seats in different programs at MGSI. The student has to confirm the seat if he/she is willing to take admission to the program where the seat is available.
- 11.7 Once the student confirms the admission, the college will lock his/her seat on the GCAS portal.
- 11.8 He then has to pay prescribed fees (online mode only) to complete the admission process. **NOTE**: After confirmation of Admission, the subjects allocated will not be changed.

12 Documents for Application

- 12.1 The student shall **submit** the self-attested copies of the following documents along with the printout of the **registration form, copy of the allotment letter** and **Receipt of the Token Fee** paid to MGSI at the stipulated date of reporting to the college for the admission process
 - SSC Examination (Std. X) Mark-sheet.
 - HSC Examination (Std. XII) Mark-sheet.
 - School Leaving Certificate or Transfer Certificate or Migration Certificate
 - 12.1.1 Caste certificate for a student belonging to Scheduled Caste (SC), Scheduled Tribes (ST), Socially and Economically Backward Classes (SEBC) issued by the authority empowered by Gujarat state government on this behalf along with valid Non–Creamy layer (NCL) certificate.
 - 12.1.2 Economically Weaker Sections (EWS) issued by the authority empowered by the State Government.
 - 12.1.3 Valid Non–Creamy layer (NCL) certificate of the family, issued by the authority empowered by the state government on this behalf.
 - 12.1.4 SEBC students must produce a certificate of non-inclusion in creamy layer issued

by the competent authority having validity for the period of three years from the date of issuance or as per the latest amendment made by the Government of Gujarat with this regard to avail the benefit of category.

- 12.1.5 Certificate of Physical Disability, issued and duly signed by the Civil Surgeon/competent Medical Authority, in case of a Physically Handicapped student.
- 12.1.6 Certificate of Ex-Serviceman, duly issued by the Director, Sainik Welfare Board, or by the District Sainik Welfare Officer.
- 12.1.7 A copy of the certificate of In-Serviceman duly issued by the Commanding Officer of the respective unit in which he/she is serving.
- 12.1.8 A copy of the Provisional Eligibility certificate for students other than the Gujarat Board. (Excluding CBSE schools situated in Gujarat)

13 Disqualification from Admission due to submission of false documents

If, during document verification or at any later stage, the Admission Committee of MGSI discovers that any certificate, testimonial, or information submitted by a student is incorrect or falsified, the student's admission will be canceled for that academic year. Additionally, the student will be disqualified from admission for the following two years."

14 Cancellation of Admission and Refund of Fees

As per the UGC policy on the cancellation of admission and refund of fees in autonomous colleges, students are entitled to refund based on the specific timelines and conditions set by the institution and UGC policy. The refund amount will vary depending on the timing of the withdrawal of admission, and deductions may apply as per the UGC policy....

Policy:

- **Full Refund:** If the admission is cancelled before the last date of admission, the entire fee will be refunded.
- 90% Refund: If the admission is cancelled less than 15 days before the last date of admission.
- **80% Refund:** If the admission is cancelled within 15 days or less after the last date of admission.
- No Refund: If the admission is cancelled more than 30 days after the last date of admission.
- These policies aim to maintain transparency and fairness while ensuring adherence to UGC regulations."

15 Vacant Seats

After offering admission to all students included in the merit list, or upon completion of the admission process, any vacant seats (if any) shall be filled by MGSI through an offline process from among eligible students, based on merit.

16 Penalty

Anyone who breaches any of the provisions of the rule or or violates any directions issued by MGSI from time to time, shall be liable to a penalty, the nature and extent of which shall be determined by MGSI.

17 In case of dispute

In an implementation of the provisions of these rules, if any difficulty or question arises as to the interpretation of any provision, the decision of the MGSI authorities shall be final. If any dispute arises, it will fall under Ahmedabad City Jurisdiction only.

18 Prevention and Prohibition of Ragging

In view of the directions of the Honorable Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students.

MANDATORY DISCLOSURE

- 1. Ragging is totally banned and anyone found guilty of ragging and/or abetting ragging is liable to be punished.
- 2. The Appendix-I (AFFIDAVIT TO BE DONE BY THE STUDENT) should be filled up and signed by them to the effect that he/she is aware of the law regarding the

- prohibition of ragging as well as the punishments, and that he/she, if found guilty of the offense of ragging and/or abetting ragging, is liable to be punished appropriately.
- 3. The Affidavit-II (AFFIDAVIT TO BE DONE BY THE PARENT/GUARDIAN) should be signed by the parent/guardian of the applicant to the effect that he/she is also aware of the law in this regard and agrees to abide by the punishment meted out to his/her ward in case the latter is found guilty of ragging and/or abetting ragging.
- 4. A student seeking admission to the hostel shall have to submit another affidavit along with his/her application for hostel accommodation that he/she is also aware of the law in this regard and agrees to abide by the punishments meted out if he/she is found guilty of ragging and/or abetting ragging.
- 5. The first-year students should desist from doing anything against their will even if ordered by the seniors, and that they have nothing to fear as the institution cares for them and shall not tolerate any atrocities against them.
- 6. A student securing admission shall have to submit concern affidavits to the principal.

Actions to be taken against students for indulging and abetting ragging in college:

- 1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against the recurrence of such incidents.
- 2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
- The Anti-Ragging Committee of the institution shall make an appropriate decision, about punishment or otherwise, depending on the facts of each incident of ragging and the nature and gravity of the incident of ragging.
- 4. Depending upon the nature and gravity of the offense as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following,
 - Cancellation of admission
 - Suspension from attending classes
 - Withholding / withdrawing scholarship/fellowship and other benefits
 - Debarring from appearing in any test/examination or other evaluation process
 - Withholding results
 - Debarring from representing the institution in any regional, national, or international meet, tournament, youth festival, etc.
 - Suspension/expulsion from the hostel
 - Rustication from the college for periods ranging from 1 to 4 semesters
 - Expulsion from the college and consequent debarring from admission to any

other institution.

An appeal against the order of punishment by the Anti-Ragging Committee shall lie,

- 1. In case of an order of a college, affiliated to or a constituent part, of the College, to the principal.
- 2. In case of an order of a college, to its Chancellor.

The institutional authorities shall intimate the incidents of ragging that occurred in their premises along with actions taken by the University from time to time.
